Entryway and Perimeter Wall Improvements

Over the last several years, new identity signs, post lamps, stone veneer, and painting were completed at the entryway at each end of Whitley Collins Drive. These improvements have been made to improve the appearance of Mesa PV as an upscale, estate-type community. These projects were funded by the homeowner association dues collected from the residents plus some limited funds from the City of RPV and RHE. A new budget to include additional project costs (improved landscaping) will be presented for review and approval at the annual meeting.

The Mesa PVHOA Board feels it is necessary to continue the improvements that appear to have helped stabilize our property values. Although the time and skills required for the planning, bidding, negotiating, inspection and disbursement functions have all been donated by Mesa volunteers, the costs of the improvements (contracted labor and materials) have proven to be very expensive, and those costs continue to rise with each successive phase.

Therefore, the Association is requesting that 2010 membership dues payments (and voluntary contributions if so inclined) be made as promptly as possible to avoid undue delay in the remaining work needed to be done. Since all the homeowners in Mesa PV benefit from these improvements, it is only reasonable to expect that all the homeowners in Mesa PV share the cost of the work. In the past there have been some who, for whatever reason, have failed to pay their HOA dues. Let's all commit our share to upgrade and enhance our community and protect our investments, and help Mesa PV's home values remain solid and stable.

Wildlife Amongst Us

It appears that the peacocks have decided to migrate from the Crestridge area into Mesa. It is against city ordinance 10.84.010 to feed peafowl, crow, pigeon, squirrel, or raccoons. If you believe a neighbor is leaving food out for any of these species, please remind them of this law or call City of RPV-Code Enforcement (310) 544-5228.

Please remember that it is against the law to park your car in front of your mailbox denying access to the mail carrier. Give our postal workers the room they need to delivery your mail. It also helps visitors and emergency vehicles find your house number.

Gardening Hours

Many residents have asked what the RPV City-approved hours are for gardeners to fire up their lawnmowers, edgers and the blowers. The hours approved for these noises are 8:00 AM to 5:00 PM Monday through Friday, and 9:00 AM to 4:00 PM on Saturdays. Your gardener may need to be reminded of these hours to avoid annoying your neighbors, and possibly the filing of complaints.

PVP Watch


