#### PRESIDENT'S MESSAGE

You may recall that when our membership approved an assessment of \$3400.00 for the irrigation project two years ago, the Board promised to do their best to commence refunding those funds in 2003. The payback was scheduled to be completed by the end of 2005, assuming the funds were available.

I am pleased to report that the Board has approved the first installment (an immediate refund of \$400.00) to our 560 members. We are delighted to be ahead of schedule. Our ability to begin the refund is related to an increase in new members. We have exceeded projections for new members this year. For instance, this month alone we anticipate accepting six people from the waiting list. Consequently, the Board has authorized our accounting department to distribute the \$400.00 payment by check to our membership within the next 30 days. A letter will accompany the check explaining the distribution comes from the unspent funds set aside for the irrigation project and the balance will come from the capital improvement fund which now exceeds \$1.5 million dollars. I am hopeful that we can continue to refund the irrigation assessment ahead of schedule.

We also have in our operations account approximately \$593,000.00 as of August 2002. The Board is mindful that following our Concession Agreement with the City, any operational funds at the end of the year exceeding \$600,000.00 must be transferred to the capital improvement fund. Therefore, we

must strike a balance between accumulating too much cash and having sufficient funds to operate comfortably. To this end, due to the hardening of the insurance market, our medical insurance has increased by 8%, property / casualty by 171%, workers compensation by 87%, and for directors and officers by 67%. This results in an estimated cost increase of \$136,000.00. Faced with the above increases as well as increased labor cost, I have asked our Committee Chairs to meet with our managers as well as their committees to strategize ways to cut costs and raise revenue. I look forward to discussing an action plan with you after our analysis is complete.

Those members, who must provide verification of property ownership to the Club, please note that the Board has agreed to defer the deadline to provide such information until October 2002. At this time, the Board and the City are discussing the merits of the residency requirement and we will continue to keep everyone abreast of the status of this important issue.

We are still having difficulties with our new sprinkler heads. Be assured; we have a guarantee by Rain Bird and our distributor that the problem will be resolved. Although our rough, greens, and tees are in excellent condition, our fairways have wet, thin, and brown spots which need to be addressed. The Board has every confidence in our course superintendent, Pat Gradoville, who is diligently working to restore and exceed the quality of our fairways to the level that

#### **SUMMARY OF BOARD MEETING MINUTES**

Summary of Board Meeting Minutes Palos Verdes Golf Club Board of Directors Meeting July 24, 2002

The Board of Directors of the Palos Verdes Golf Club met on Wednesday, July 24, 2002, beginning at 5:30 p.m. and continuing in regular session through 7:39 p.m. Mr. Spirito chaired the meeting.

#### 1. Approval of Minutes

The Board of Directors voted to approve the Minutes of the June 26, 2002 Board of Directors meeting as submitted.

- President's & Secretary's Reports: Mr. McNamara was asked to submit draft minutes to the Club's Managers for review and input before final approval by the Board.
- 3. Old Business

A. None

#### 4. New Business

#### A. Financial Report:

1. Health-Insurance Costs: Mr. Ruszak reported that the Club has changed its medical-insurance provider from Blue Shield to Blue Cross. The coverage provided by Blue Cross is similar to that was provided by Blue Shield. The cost increase associated with this move is roughly 8%; this increase is less than would have been the case had the Club stayed with Blue Shield. Blue Shield quoted an increase of 24%. The Insurance Committee and our Medical Insurance Broker have

advised the Club to expect an increase next year more in line with the increase quoted this year by Blue Shield, which we were able to avoid for a year by switching to Blue Cross. 2. Property, Casualty, & Umbrella Insurance: The Club's insurance provider, Fireman's Fund, has increased its premium for the coming year by roughly \$65,000 - from approximately \$38,000 to \$103,000, or 171%. After surveying available options, the Insurance Committee recommended renewing the policy with Fireman's Fund. The Board approved this recommendation, as the expenditure exceeds that included in the Club's budget. Justifications provided by the Club's broker for the premium increase included the Club's loss history and state of the insurance industry. Based on these factors and the low renewal premium quoted by Firemen's Fund (at least as perceived by the other carriers), the other carriers contacted by the Club's broker declined to quote.

- 3. Significant increases in the Club's Worker's Compensation and D&O insurance are expected next year.
- 4. The Club remains open to receiving bids or suggestions from those interested in brokering insurance for the Club.
- 5. The Club's financial package is not yet completed; the delay is due primarily to schedule impacts related to an employee's medical condition in the Accounting area.
- B. <u>Termination of Membership</u>: The Board voted to terminate the Membership of Hyun Sup Park.
- Committee Reports: Reports from various Committees were distributed and reviewed. In addition, the following discussions occurred:
  - A. <u>Barranca</u>: The Board voted to require that future Letters to the Editor be submitted to the Board. Although future letters generally will not be published, the Board decided to publish all letters that had been submitted before the policy was adopted.
  - B. Membership: The Membership Committee has been alerted that a number of non-Members are playing more than the three times a month permitted by the Club's Rules. The situation will be investigated by the Golf Committee, which will report back to the Board on the issue.
  - C. <u>Golf:</u> The Board discussed requests by the Palos Verdes Tennis Club and Palos

Verdes Breakfast Club to conduct tournaments at PVGC.

#### D. Green:

- 1. Adjustments continue on the Rain Bird sprinkler system to eliminate the dry and wet spots on the course. The problem, as acknowledged by Rain Bird, appears to be with the sprinkler head nozzles supplied by Rain Bird. Rain Bird is committed to reaching an acceptable solution.
- 2. The Club's landscape architect will be asked to submit ideas to beautify the area on the north side of the Clubhouse where the palm trees were removed.

#### E. House:

- 1. The Committee is investigating the ability to serve liquor on the patio adjacent to the Snack Bar.
- 2. Additional tables and chairs are being purchased for the patio adjacent to the Snack Bar.
- 3. The Long-Range Planning Committee has been asked to consider potential improvements needed for the Snack Bar.
- F. Long-Range Planning: A model showing potential changes to the Clubhouse would cost approximately \$5,000. The Board discussed whether such a model was needed or appropriate at this time and made it plain that it has not yet approved this expenditure. The Board suggested that it would be appropriate to ascertain the ability to raise necessary funds before proceeding to have a model constructed.

#### G. Scholarship:

- 1. The Board approved providing the Committee with discretion to increase the scholarship by \$500 if the Committee decides that it needs such an increase.
- 2. The Board discussed the possibility of setting up a charitable fund for scholarships.
- 6. Executive Session The Board adjourned and met in Executive Session from 7:39 to 8:15 p.m. The Board discussed personnel and compensation issues; the need to conduct the residency audit; and the favorable resolution of the *Patton* litigation with summary judgment being granted against Patton and in favor of the Club, and Patton's dismissing his lawsuit with prejudice against the City.
- 7. **Adjourn** There being no further business, the Meeting adjourned at 8:51 p.m.

#### **GOLF TIP**

Using a putter from off the green is a lot safer than trying to nip the ball perfectly with a wedge. If you are just in front of the green and have a clear path to the hole, a higher percentage shot for most players is to putt the ball. It is easier to putt than to chip off the tight Kikuyugrass around the greens. You do not have to modify your stroke, use your same setup, but you will need to hit the putt a little harder than usual to compensate for the longer fairway grass. Once the ball reaches the green, it will pick up speed. Try to focus on dying the ball within three feet of the hole..

#### **RULES BY RAY**

This September we start the Men's Partner Better Ball Tournament. Under this format, the contestants will be governed by Rule 30 of the USGA Rule Book, *The Rules Golf.* 

# DEFINITION- RULE 30 THREE BALL, BEST BALL, AND FOUR-BALL MATCH PLAY.

In four-ball match play two competitors play as partners, each playing his own ball. The lower score of the partners is the score for the hole. If one partner fails to complete the play a hole, there is no penalty. Four Ball is a match in which two partners play their better against the better ball of two others.

### IMPORTANT ELEMENTS IN FOUR-BALL PLAY:

- There are strategic options, which allows partners to decide who plays first. For example, one partner may elect to putt out before his partner plays a long putt.
- If your ball is deflected by your partner, caddie, or equipment (which includes a cart you are sharing), you

- are disqualified for that hole, but not your partner.
- When your ball is deflected or stopped by something on the opponent's side there is no penalty, but you get an option. To either replay the stroke or play the ball as it lies.
- When a player violates a Rule, your partner is not penalized unless the nature of the violation helps your partner or hurts the play of an opponent.
- If one player on a team is late, or never shows up at all, the remaining player can play against the other team. The missing player can join the match in progress at the start of any hole.

Someone asked me what team has the best chance to win. I predict, and I am someone who does not play favorites, that a dark horse is going to come out of the pack and surprise the field. My long shot pick of the contest is the team of Dan Booker and Ed Hollis!

#### **TURF TALK**

■ all is right around the corner as the football season begins and baseball; I do not want even start in on that! I would like to discuss some basic golf course etiquette issues that we have noticed around the golf course. There has been a significant increase in the number of bunkers left unraked and ball marks that are not repaired. The maintenance staff rakes each bunker every morning. Please help everyone and do your best to leave the course in better condition than you found it. If every golfer followed this rule, what a difference it would make. I challenge each member to fix an extra ball mark, and fill an extra divot. Together, we can make a difference. Remember that you cannot move a boulder alone, but together, we can move a mountain.

Around the course, the fairways quickly responded to limiting golf cars to the paths at the end of August. The thin spots that were on several fairways have greatly been reduced, and the Kikuyugrass seed that was planted is beginning to fill in rapidly. The thin spots were caused by

Poa annua and ryegrass dying out due to drought stress and a short root system, common in heavy clay soils, which we have. There has been a resolution to the sprinkler nozzle problem we have been experiencing. With the original nozzle installed with the new irrigation system, too much water was being distributed around each sprinkler head, leaving a wet spot. To combat the wet area, we had to reduce the time that sprinkler ran, which created a dry area about 20 feet from the sprinkler. Rain Bird has developed a new nozzle combination that we feel will correct the situation. It has been installed on several holes around the course and seems to have corrected the situation. Thank you for your understanding of our dilemma and for being patient while we correct the situation.

With the fall season rapidly approaching, we are once again encouraging golf cars to 'Scatter' throughout the course to minimize concentrated traffic. We implemented this same policy last year in the fall and it seemed to work well. So



until next spring, golf cars are *encouraged* to drive throughout the course. Please be aware to stay out of areas of the course that are roped off or where signs are in place, directing you where to go.

Elsewhere around the course, I am sure you have noticed two new "members", two white ducks. They have been with us now for several weeks, and nobody has seen them fly away so we believe they will be with us for a while. Recently, a hawk from the driving range had one of the ducks in its claws and flew off with it, but the duck managed to escape and appears to have fully recovered from the incident!

#### THE HANDICAP COMMITTEE REPORT – AUDIT

On July 30, 2002, the Handicap Sub-Committee of the Golf Committee conducted an audit of the Golf activity of Friday, July 19, 2002. The audit was performed by Kay Lashbrook, Scott Coale, Fred Shuss, Jim Gormley, and Keith Stafford. It took about two hours to complete. We estimate that future audits will require about four person-hours.

The objective of the audit was to gather information on the posting habits of our members. Here are the important data:

Rounds Played - Total	241
Rounds Played - Members	132
Rounds Posted - Members	91
Rounds Not Posted - Members	41

Thirty one percent of our members did not post a round. There were 13 members who posted a round, but whose name did not appear on the sign-up sheet.

There were 18 scorecards turned in representing 43 members. Only two scorecards had totals, and only 23 out of 43 had SCGA member numbers.

#### CONCLUSIONS

One third of our members did not post a score. Two-thirds of our members did not turn in a scorecard. The majority of cards turned in were not filled out properly.

#### **RECOMMENDATIONS**

We will continue spot audits. The results of our next audit will be published. We will list the members who failed to post, failed to turn in a scorecard, improperly filled out a scorecard, or failed to sign up in the Pro Shop. We will also post the most poorly filled out scorecards.

New member orientations will include face to face meetings between new members and representatives of the Membership Committee to review guidelines, both verbally and in written format. This will help to improve the shortcomings we now have, at least with new members.

Our membership should bring up any Handicap Issues with the Board or the Golf Committee, *not the Pro Shop staff*.
